Tour price is subject to change should airline and exchange rate is always subject to prevailing at the time of payment, or due to increases / or introduction of any new surcharges levied by the suppliers / airlines. Passengers will have to strictly follow the tour itinerary as per the amendments made by the tour manager or local representative / guide. There will be no refund for any unutilized services.

(2) It would be understood that a passenger has read and understood the itinerary cost, payment schedule and terms & conditions of Zenith Leisure Holidays Ltd. before signing the Tour registration Forms or / and making payments towards part consideration of the tour.

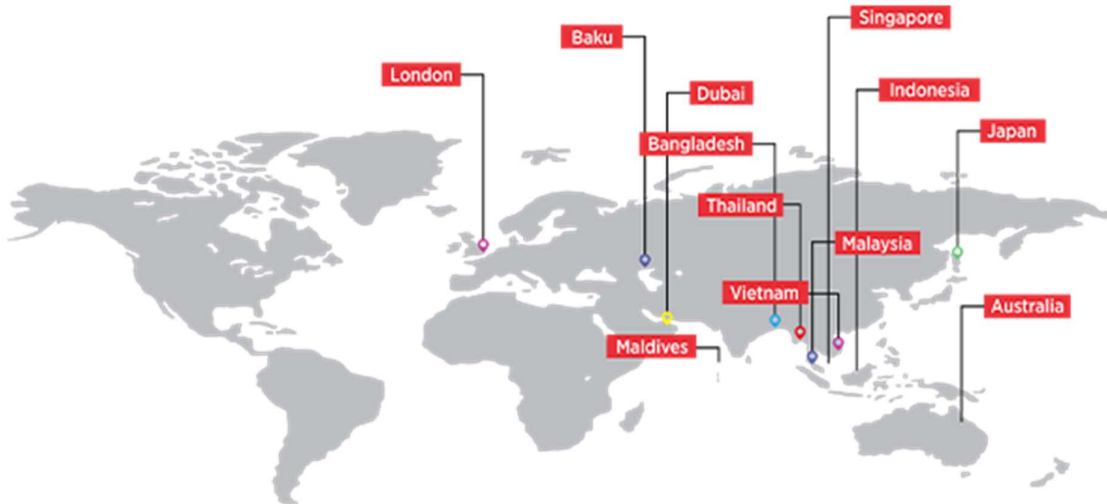
